CORRIGENDUM IN FINAL ORDER DATE 27.11.2018 DATE: 11.12.2018

The Fee Regulatory Committee has passed the final order on 27.11.2018 for the academic year 2017-18 for pre-primary, primary, upper primary, secondary and Cambridge (Higher Secondary), as under:

On receipt of the final order, the school vide its letter dated 7.12.2018, drew the attention of the committee that there is significant discrepancy in para 6 of the communication which mentions the final fees determined by the committee. In para 6 of the order, the provisional and final fees determined by the committee for the academic year 2017-18 for Cambridge (Higher Secondary) are mentioned as Rs.80,000/- and Rs. 84,500/-. However, these two categories namely Cambridge and Higher Secondary are separate. A request was therefore made to delete the word "Cambridge" from the standard "Higher Secondary". It is further pointed out that the school had not raised any objection in relation to the fees provisionally fixed for the Cambridge Board. It is therefore further requested that the final fees for Cambridge Board may also be determined along with the fees for other standard.

The committee has gone through the record and contents of the letter dated 7.12.2018. The issue raised by the school is found to be acceptable and final fees for higher secondary as well as Cambridge Board are required to be separately determined by the committee. The committee therefore modifies its earlier order dated 27.11.2018 and hereby passes a fresh corrigendum order rectifying the mistake inadvertently committed in the final order dated 27.11.2018.

In view of the above clarification, the committee hereby determines the final fees for the academic year 2017-18 as under:
